PROFESSIONAL AFFILIATE APPLICATION

A **Professional Affiliate** is any individual who has a professional relationship with a Florida Certified Public Accountant and does not hold a certificate as a Certified Public Accountant. Such individuals may not offer any tax or accounting services to the public, and does not otherwise qualify under a different category of membership. In addition, an eligible Professional Affiliate must provide a letter of recommendation from a Florida Licensed CPA who is a current FICPA member in good standing. Professional Affiliate members may only designate themselves as Professional Affiliate members of the FICPA. The Professional Affiliate member must act in accordance with the code of conduct and adhere to all other membership requirements. This classification includes chapter membership but does not include committee service or voting rights. **Membership valid through June 30, 2018.**
